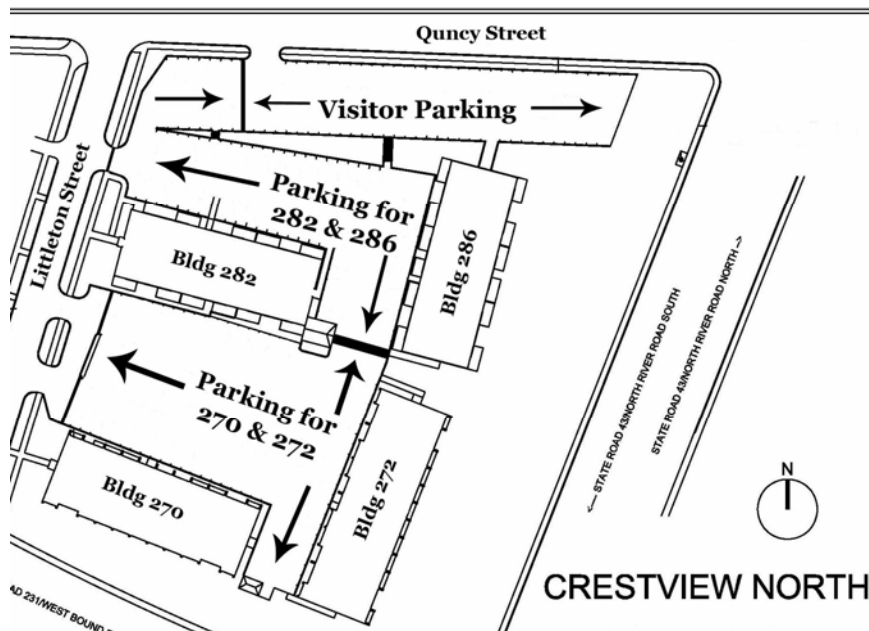


Vehicles will be TOWED WITHOUT WARNING IF:

- The vehicle is improperly parked (within and parallel to yellow lines, in a fire lane, on the lines, in the grass or blocking a dumpster).
- The permit is incorrectly placed (taped to an inside window).
- The permit is not the current school years.
- The permit does not match the vehicle registered with CV.

Crestview North:

- Carports are reserved spaces for residents who have leased them. Unauthorized vehicles will be towed!
- Residents of the 282 & 286 buildings shall park in spaces up to the garage at the east end of the 282 building.
- Residents of the 270 & 272 buildings shall park in spaces south of the garage.
- If parking is full in the designated area, residents shall park in the Visitor's lot off of Quincy Street.
- Residents' guests must use the Visitor's lot off of Quincy Street.
- Unauthorized vehicles parked in un-gated areas by the office will be towed IMMEDIATELY.

Parking Policies

- Only ONE permit per resident will be issued. Replacement permits will not be issued without proof of the sale of the vehicle.
- Crestview is not responsible for the loss or damage of any motorized vehicle.
- Permits must match the resident’s vehicle registered above.
- Permits must be placed on the left corner of your rear bumper. DO NOT place permit in your window.
- Vehicles will be **TOWED WITHOUT WARNING IF:**
 - The vehicle is improperly parked (in a fire lane, outside the lines, taking up more than one space, in the grass or blocking a dumpster)
 - The permit is incorrectly placed (taped to an inside window)
 - The permit is not for the current school year.
 - The permit does not match the vehicle registered with CV.
- **Crestview North:**
 - Carports are reserved spaces for residents who have leased them. Unauthorized vehicles will be towed!
 - Residents of the 282 & 286 buildings shall park in spaces up to the garage at the east end of the 282 building.
 - Residents of the 270 & 272 buildings shall park in spaces south of the garage.
 - If parking is full in the designated area, residents shall park in the Visitor’s lot off of Quincy Street.
 - Residents’ guests must use the Visitor’s lot off of Quincy Street.
 - Unauthorized vehicles parked in un-gated areas by the office will be towed IMMEDIATELY.
 - All scooters, mopeds, and motorcycles must park near bicycle parking and not in parking spaces or on sidewalks.
